# RDA Australia Bequests

Your bequest can be used by RDA Australia to deliver our services to people with disabilities.

You can leave a Bequest In a number of different ways, from leaving a percentage of your estate to a specific amount of money. If you wish to do this, we recommend you use the following wording.

### 1. Charitable Gift

1. My trustees hold my estate on trust, and I direct my trustees:
  - a. ...
  - b. To give the sum of @ (\$@) OR to give @ (describe specific bequest of real or personal property) OR @% of my estate OR @% of the residue of my estate OR the whole of my estate OR the residue of my estate free of all duties and taxes payable upon or in consequence of my death to **RIDING FOR THE DISABLED ASSOCIATION OF AUSTRALIA LIMITED (ACN 116 408 587)** of @ (address), for its general purposes OR for the purposes of @ (provide options for specific purposes that testator can suggest, if any); and the receipt of the secretary, treasurer or other appropriate officer for the time being of **RIDING FOR THE DISABLED ASSOCIATION OF AUSTRALIA LIMITED** shall constitute full and sufficient discharge to my trustees;
  - c. ...

You can also choose for your Bequest to be used for a specific purpose. In this instance, we recommend the wording below.

### 2. Charitable Gift – with substitution

2. My trustees hold my estate on trust, and I direct my trustees:
  - a. ...
  - b. To give the sum of @ (\$@) OR to give @ (describe specific bequest of real or personal property) OR @% of my estate OR @% of the residue of my estate OR the whole of my estate OR the residue of my estate free of all duties and taxes payable upon or in consequence of my death to:
    - i. **RIDING FOR THE DISABLED ASSOCIATION OF AUSTRALIA LIMITED (ACN 116 408 587)** of @ (address), for its general purposes OR for the purpose of @ (provide options for specific purposes that testator can suggest, if any); or
    - ii. In the event that this gift cannot take effect completely or at all, and to the extent that it cannot take effect, the charitable organisation or organisations which my trustees consider most nearly fulfils or fulfil the objects that I intend to benefit; and the receipt of the secretary, treasurer or other appropriate officer for the time being of **RIDING FOR THE DISABLED ASSOCIATION OF AUSTRALIA LIMITED** shall constitute full and sufficient discharge to my trustees;
  - c. ...
